Introduction

This policy statement sets out arrangements for managing the access of providers to students for the purposes of providing them information about the provider's education or training offer.

Student entitlement

Students in Years 7to13 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point.
- To hear from a range of local providers about the opportunities they offer, including vocational, technical education and apprenticeships through options evenings, assemblies and group discussions and taster events.
- To understand how to make applications for the full range of academic, vocational and technical courses.

The Grey Coat Hospital can make the main hall, classrooms or private meeting rooms available for discussions between the provider and students, as appropriate to the activity. Providers are welcome to leave a copy of their prospectus or other relevant course literature with our Careers Co-ordinator who will distribute the relevant information to pupils.
